Riverton Village Board

The President and the Board of Trustees of the Village of Riverton held their regular board meeting on September 20, 2021 at the Riverton Village Hall, Riverton, IL.

The board meeting was called to order at 7:01 pm. Those answering roll call: Trustees: Russ Patrick, Dave Charles, Gina Rusciollelli, Joe Bartley, Jim Mileham, Michelle Landess, and Mayor Tom Rader.

Trustee Landess made a motion to ratify patching work completed by Ron Furman for \$9300. Trustee Bartley seconded. Trustees Patrick, Charles, Rusciollelli, Bartley, Mileham, and Landess voted yes.

Trustee Bartley made a motion to approve September 7th board meeting minutes and pay the bills. It was seconded by Trustee Mileham. Trustees Patrick, Charles, Rusciollelli, Bartley, Mileham, and Landess voted yes.
