The President and the Board of Trustees of the Village of Riverton held their regular board meeting on November 15, 2021 at the Riverton Village Hall, Riverton, IL.

The board meeting was called to order at 7:05 pm. Those answering roll call: Trustees: Russ Patrick, Gina Rusciolelli, Jim Mileham, Michelle Landess, and Mayor Tom Rader. Trustees Dave Charles and Joe Bartley were not in attendance.

Trustee Mileham made a motion to approve November 1<sup>st</sup> board meeting minutes and pay the bills. It was seconded by Trustee Rusciolelli. Trustees Patrick, Rusciolelli, Mileham, and Landess voted yes.

Trustee Mileham made a motion to approve Ordinance 21-018 An Ordinance for the Levy and Assessment of Taxes for the Village of Riverton, Illinois for the Fiscal Year Beginning May 1, 2021 and Ending April 30, 2022. Trustee Landess seconded. Trustees Patrick, Rusciolelli, Mileham, and Landess voted yes.

Trustee Patrick made a motion to approve Resolution 21-003 A Resolution Abating the Direct Annual Real Estate Tax in the Amount of \$346,962.00 for the Year 2021 Levied Pursuant to Ordinance 2017-025. Trustee Mileham seconded. Trustees Patrick, Rusciolelli, Mileham, and Landess voted yes.

Trustee Mileham made a motion to approve Ordinance 21-019 An Ordinance Amending Chapter 112 of the Riverton Code of Ordinances (Trailer Parks). Trustee Patrick seconded. Trustees Patrick, Rusciolelli, Mileham, and Landess voted yes.

Trustee Mileham requested to table Ordinance 21- 020 An Ordinance Establishing Utility Rates For 2022.

Village Engineer Kevin Kuhn reported that they are still working on Rural Development projects. The plans for the SIC plant have been approved. Mayor Rader inquired about blacktop projects from the Butler money. He reported that they plan to send for bids this winter.

Trustees Patrick, Rusciollelli, Mileham, and Landess voted yes.
