

ORDINANCE NO. 19-037

AN ORDINANCE ESTABLISHING UTILITY RATES FOR 2020

WHEREAS, Chapter 50 of the Village Code of Ordinances states that every December thereafter, the Utilities Committee shall report any such percentage increase or decrease in the overhead expenses of the various utility departments to the Village Board, which report shall be placed in the minutes of the meeting, and on January 1 of every year thereafter, the base rates established will be increased or decreased by the percentage increase reported by the Utilities Committee, unless the Village Board by ordinance determines otherwise;

WHEREAS, the Utilities Committee has rendered its report to the Village Board, and the Board desires to establish rates for 2020 by ordinance;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RIVERTON, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Utility rates for the calendar year beginning January 1, 2020 shall be as follows.

ELECTRIC

(1) Residential– inside corporate limits of Riverton.

(2) Commercial and governmental– inside or outside corporate limits of Riverton.

(3) Residential– outside corporate limits of Riverton.

(5) Senior citizens– (inside corporate limits of Riverton only).

Rates for usage over 10 kwh will be determined by adding the cost of the purchased electric to the cost of the per unit overhead cost as determined by the review of the audit.

ELECTRIC----NET METERING CUSTOMERS

The Village has instituted a net metering system for customers who wish to participate in that program. Those customers must sign an **AGREEMENT FOR INTERCONNECTION AND PARALLEL OPERATION OF DISTRIBUTED GENERATION** with the Village, and the following rate schedule shall apply to those customers:

- A. A monthly administrative fee will be paid to the Village in the amount of \$20, to offset the expenses incurred by the Village in the operation of this program. In addition, any customer participating in this program must remain current on all other utility charges
- B. Each customer will be charged the actual costs of establishing and maintaining the interconnection with the Village, as set forth in the **AGREEMENT FOR INTERCONNECTION AND PARALLEL OPERATION OF DISTRIBUTED GENERATION**.
- C. The Village will reconcile net metering accounts each July, by reading the customer meters in the July billing cycle each year. Any usage above net zero will be billed to the customer, by dividing that net usage figure into a monthly average, and applying the monthly rate structure set out above. Payment is due from the Customer in the regular billing cycle of the Village.

GAS

(A) The base monthly rate for natural gas service inside corporate city limits of the village based on furnishing one thousand BTU per cubic foot natural gas at sixty degrees Fahrenheit are as follows:

(1) For general and space heating use:

(a) First one thousand cu. ft.

(b) Every one thousand cu. ft. thereafter-- Based on gas purchase price + distribution/overhead cost

(B) The base monthly rate for natural gas service outside corporate city limits of the village based on furnishing one thousand BTU per cubic foot natural gas at sixty degrees Fahrenheit are as follows:

(1) For general and space heating use:

(a) First one thousand cu. ft.

SEWER

(a) The monthly charge for sewer services shall be based on the amount of water consumed as measured at the customer's meter, as follows:

1. All users-- inside corporate limits of Riverton:

Demand charge-- for availability of sewage treatment and for treatment of up to first one thousand gallons:

For water used in excess of one thousand gallons:

2. All users-- outside corporate limits of Riverton:

Demand charge-- for availability of sewage treatment and for treatment of up to first one thousand gallons:

\$17.49	\$17.75

For water used in excess of one thousand gallons:

\$5.79 per thousand gallons	\$6.05 per thousand gallons

3. Surcharge for Exceptional Loads. For users of the sewage system with sewage discharge concentrations exceeding two hundred mg/l BOD or two hundred sixty-six mg/l SS, there will be a surcharge, as follows:

per pound of BOD: \$.308 per pound

per pound of SS: \$.235 per pound

(b) Minimum payment for persons who are obligated to connect to the village sewage system: All persons who are required by Section 54.004 of this code of ordinances to connect to the village sewer system, but who have not done so, shall be liable to pay the demand charge of


