Riverton Village Board

The President and the Board of Trustees of the Village of Riverton held their regular board meeting on November 17, 2025, at the Riverton Village Hall, Riverton, IL.

The board meeting was called to order at 7:03 pm. Those answering roll call: Trustees, Johnathan Chisam, Dave Charles, Gina Rusciolelli, Joshua Zirkelbach, Jim Mileham, Michelle Landess, and Mayor Joe Bartley.

The Pledge of Allegiance was recited.

Trustee Mileham made a motion to approve November 3rd board meeting minutes and pay the bills. It was seconded by Trustee Landess. Trustees Chisam, Charles, Rusciolelli, Zirkelbach, Mileham, and Landess voted yes.

Trustee Chisam made a motion to approve bids for Overpass Road for PH Broughton & Sons Inc for \$165,000 from MFT Funds. Trustee Charles seconded. Trustees Chisam, Charles, Rusciolelli, Zirkelbach, Mileham, and Landess voted yes.

Village Engineer Kuhn, reported that they are waiting for outstanding grants and the pond at the Field of Dreams is in the design stage.

Village Attorney Craven, reported that the concerns regarding the water tower are ongoing.

Superintendent Lyons, was not in attendance.

Chief Crouch, submitted his report.

Office Manager Patterson, had nothing to report.

Treasurer March, reported that the Tax Levy would be presented at the next meeting.

Committee Reports:

Trustee Zirkelbach, chairperson of the Administrative Committee, reported that the Health Insurance Committee met and are continuing with the established health insurance.

Trustee Rusciolelli, chairperson of the Public Safety Committee, had nothing to report.

Trustee Mileham, chairperson of the Public Utility Committee, made a motion to approve \$10,684.02 to Brotke Well Service to replace and repair pumps and pipes at Well 5. Trustee Landess seconded. Trustees Chisam, Charles, Rusciolelli, Zirkelbach, Mileham, and Landess voted yes. He

thanked the village employees for putting up the Holiday Lights and gave an update on village projects.

Trustee Charles, chairperson of the Parks Committee, reported that the fitness equipment for the Field of Dreams has arrived and thanked Village Engineer Kuhn for his continued work on the OSLAD grant.

Trustee Chisam, chairperson of the Public Works Committee, had nothing to report.

Trustee Landess, chairperson of the Economic Development Committee, reported that the Public Works employees would be changing hours back to 7 – 3:30, Dump Day winter hours are 8-10 effective December 6 and that the Village offices are closed on November 27 and 28th. She inquired about the Holiday Lights contest. Mayor Bartley reported that it would be judged the week of December 8-12th for Large and Small categories and winners announced on December 15th.

Mayor Bartley reported that the Village Employee Holiday Party would be held at the KC Hall on December 11. He also gave an update on the Hazardous Mitigation Committee.

Trustee Mileham made a motion to enter executive session at 7:16 pm. Trustee Rusciolelli seconded. Trustees Chisam, Charles, Rusciolelli, Zirkelbach, Mileham, and Landess voted yes.
