The President and the Board of Trustees of the Village of Riverton held their regular board meeting on September 2, 2025, at the Riverton Village Hall, Riverton, IL.

The board meeting was called to order at 7:00 pm. Those answering roll call: Trustees, Johnathan Chisam, Dave Charles, Gina Rusciolelli, Joshua Zirkelbach, Jim Mileham, Michelle Landess, and Mayor Joe Bartley.
