### Riverton Village Board

The President and the Board of Trustees of the Village of Riverton held their regular board meeting on February 5, 2024 at the Riverton Village Hall, Riverton, IL.

The board meeting was called to order at 7:00 pm. Those answering roll call: Trustees: Johnathan Chisam, Dave Charles, Gina Rusciollelli, Jim Mileham, Michelle Landess, and Mayor Joe Bartley.

The Pledge of Allegiance was recited.

Trustee Mileham made a motion to approve January 16<sup>th</sup> board meeting minutes and pay the bills. It was seconded by Trustee Landess. Trustees Chisam, Charles, Rusciollelli, Mileham, Landess, and Mayor Bartley voted yes.

Rose Hughes addressed the board regarding development on Overpass Road. They have concerns about the building, drainage, fence, and roadway. Superintendent Lyons said they would investigate putting a sign on the road and addressing the speed limit to limit concerns.

Trustee Mileham, chairperson of the Public Utility Committee, made a motion to approve \$400 for four employees to attend a gas training. Trustee Rusciollelli seconded. Trustees Chisam, Charles, Rusciollelli, Mileham, Landess, and Mayor Bartley voted yes.

Trustee Charles, chairperson of the Parks Committee, reported that he would be meeting with Superintendent Lyons regarding projects.

Trustee Landess, chairperson of the Public Works Committee, scheduled a committee meeting for March 4 at 6:30 regarding the budget. She also thanked Jimmy Ford for 20 years of service to the village.

Mayor Bartley, chairperson of the Economic Development Committee, reported that the new Dollar General Market on Overpass Road is projected to be open by mid May.

Mayor Bartley, reported that he attended a regional leadership meeting and IML recommended that the village employees receive training regarding cyber security. He also said that he attended a strategic planning meeting with the school district.

Trustee Rusciollelli made a motion to adjourn the meeting at 7:27 pm. Trustee Landess seconded. Trustees Chisam, Charles, Rusciollelli, Mileham, Landess, and Mayor Bartley voted yes.
