The President and the Board of Trustees of the Village of Riverton held their regular board meeting on October 21, 2024 at the Riverton Village Hall, Riverton, IL.

The board meeting was called to order at 7:00 pm. Those answering roll call: Trustees: Johnathan Chisam, Dave Charles, Gina Rusciollelli, Jim Mileham, Michelle Landess, and Mayor Joe Bartley.

Mayor Bartley reported that FJ Murphy had given a quote to service and update the Village Hall sprinkler system. Trustee Landess made a motion to approve \$2,350 for the sprinkler system service and update. Trustee Rusciollelli seconded. Trustees Chisam, Charles, Rusciollelli, Mileham, Landess, and Mayor Bartley voted yes.
